The Board of Management recognises that child protection and welfare considerations permeate all aspects of school life and must be reflected in all of the school's policies, procedures, practices and activities in its policies, procedures, practices and activities, the school will adhere to the following principles of best practice in child protection and welfare: The school will:
 - Recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations
 - Fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare children;
 - Fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters
 - Adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
 - Develop a practice of openness with parents and encourage parental involvement in the education of their children; and
 - Fully respect confidentiality requirements in dealing with child protection matter.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- 5. The following procedures/measures are in place:
 - In relation to any member of staff who is the subject of any investigation (however
 described) in respect of any act, omission or circumstance in respect of a child attending
 the school, the school adheres to the relevant procedures set out in Chapter 7 of the Child
 Protection Procedures for Primary and Post Primary Schools 2017 and to the relevant
 agreed disciplinary procedures for school staff which are published on the DES website.

- Risk of harm due to inappropriate relationship/communications between child and another child or adult
- Risk of harm due to children inappropriately accessing/using computers, social media, phones and other devices while at school
- Risk of harm to children with SEN who have particular vulnerabilities
- Risk of harm to child while a child is receiving intimate care
- Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in appropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner
